1. Report on Students Feedback

Dear Sir,

This is with the reference to the revised syllabus of B.A (CBCS-2018) as per the feedback from the students and faculty. Every year we receive a number of complaints by the students and staff on the Examination and Evaluation System of Gulbarga University Kalaburagi. Hence it is our observation against action of analysis of feedback.

1. Parent University should have organized workshop to the faculty on CBCS before introducing it. There is no clarity in Generic Elective, Skill Enhancement course and open Elective subjects.

2. Reduction of credits from 4 to 3 to all languages for basics is strongly opposed by all the language teachers as per their feedback. It has lead to loss of workload to

language teachers.

3. As parent University implemented CBCS in semester pattern to all colleges, the syllabi prepared by BOS is huge for faculties are unable to conclude within allotted time period. On account of which there may be tremendous academic loss

as per feedback opinion of pupils.

- 4. Semester pattern as implemented by parent University is strongly opposed by many of the students and faculties as per their feedback opinion for the students being busy in preparing the examination while the faculty being active in completing syllabi completely neglecting co curricular and extracurricular activities.
- 5. As the parent University extends the date of admission to supplementary student who are given another opportunity to get through their exams up to the middle of August every year, furthermore the University circulates the commencement of University exam from 1st week November, due to which late admitted students are unable to prepare properly with short span of period for examination for being huge syllabus.

6. Students feedback clearly shows students dissatisfaction towards University examination late fee for UG students as compared to other Universities of the state. They feel that the late fee for UG students compared to PG students is very

heavy and unscientific.
